# **Pond Update**

The SOA ponds at Lost Park Ranch are both in operating condition. Over the past year, a problem with the overflow spillway was corrected by SOA. The biggest concern we will have this year is whether there will be adequate runoff to keep the ponds fishable this summer. Since the ponds are a bit more shallow, if there is not enough cold water coming in, the water temperature will rise and may not sustain trout.

The LPROA pond by Stagestop developed a huge weed growth last summer. With so many weeds, we believe that as weeds die and decay, they are likely to cause very poor water quality. Volunteers worked for numerous days last summer and fall to remove as many willows and weeds as possible from the surface of the water but were not able to get all of the floating weeds. Many of the weeds that were dragged out of the water are just sitting at the edge of the pond and must be removed before more water is pumped in and fish are



# Catch and Release Dos and Don'ts for Handling Fish

#### Don'ts

- Don't fight a fish too long. Try to land the fish as quickly as you can without injury to the fish.
- Don't wear gloves of any kind. A bare wet hand is best.
- Do not lift the fish out of the water for more than three seconds as this puts added stress on the abdomen area.

#### Dos

- ♦ Do Fish with a crushed barb hook
- Do Carry pliers or hemostat to easily remove the hook
- Do cradle the fish with a soft grip, putting one hand on the wrist of its tail and one under its belly.
- Do hold the fish pointing upstream and into the current.
- Do have your camera on and in the correct mode, ready to shoot
- Do work as fast as you can when taking photos.
   Take one shot and if it doesn't work, let the fish go without a picture.

# **TFC Parking and Access Points**

- 1. Firehouse at Stagestop (uppermost point)
- The LPROA water augmentation pond near Stagestop
- 3. Stream gage downstream from Rock Creek.
- Forest Service land next to Topaz Mountain Ranch road.
- State land before road to Lost Park Ranch (end of our fishing lease).

Caution: If you open a gate, close it behind you.

Now that the Federal Highways Dept. has completed the section of County Road 77 that runs alongside our fishing lease, you may be wondering where you should park.


**Points 1 and 2:** The firehouse at Stagestop and the LPROA water augmentation pond near Stagestop remain unchanged.

**Point 3:** To access the stream at the stream gage downstream from Stagestop, park along the road where the gates allow cattle to bypass the cattle guard. The land on both sides of the cattle guard is public land.



Facing North—both sides of the gate are public land

**Point 4:** To access the stream at the "Thornton access" from the Forest Service land next to Topaz



Mountain Ranch road, you can park on the paved pullout along CR 77 just north of the gates into Topaz Mtn Ranch. Cross the road and there is public land is to the north of the two gates installed on the dirt road to Topaz Mountain Ranch (to your right as you face the gates). Public land extends to the river. The access purchased for the TFC begins at the second gate and runs south from the 2nd Topaz gate along the right side of the fence to the river.



Facing South—pullout is on left.

**Point 5:** To access the river at the State of Colorado area, park in the

designated State parking area.
Cross the fence at the walkover then proceed down to the large



metal gate. Go through the 3-point walk-through to the left of the gate. At the river, you can climb over the fence to go upstream. (Please do not park out on the rocky point just north of the State parking, it is on private land.)



From State parking to 3-pole walkthrough.

Reminder: TFC members are allowed to access the river ONLY at authorized ingress/egress points and must stay within 20 feet of the river at all times. If you are unfamiliar with the access points, refer to the map or contact a board member for directions.

# Who Can Use a Membership Card?

Membership cards are for the use of a lot owner (whose name is on the property deed) and a spouse or one other adult owner (whose name is on the property deed) – a maximum of two adults per lot.

If more than two adults own a lot, only two of the owners may use a membership card - all other owners must use guest passes.

Children, age 16 or under, do not need a guest pass but must be in the company of an adult with a membership card or guest pass.

## Who Must Use a Guest Pass?

Anyone who is not entitled to use a membership card as defined above must use a guest pass.

When there are multiple owners of a single lot and more than two owners want to fish, the group of owners must decide among themselves who uses the two membership cards. All others must use guest passes.

Owners are responsible for their guests and for insuring proper use of guest passes, including signing and dating in ink.

# **Vehicle Hang Tag**

Each dues-paying lot is issued one vehicle hang tag. The hang tag is to be used in your vehicle while parked near the area you are fishing. A hang tag does not substitute for a membership card or a guest pass.

# "No Fishing" Days

**Fish Stocking days are no-fishing days.** Please refrain from fishing on stocking days to give the fish a chance to recover from the transport.

# Fishing License Requirement.

Anyone over 16 years of age who fishes in the ponds or the stream lease is required to have a Colorado fishing license.

# TFC RULES VIOLATION POLICY

Fines will be assessed against a lot for rules violations by the lot owner or the lot owner's guests.

# Penalties as follows:

- First violation: Warning letter
- Second violation: \$50 fine
- Third & subsequent violations: \$100 fine
