FISHING RULE CHANGES

Due to costs, we are limiting guests/guest pass holders to keep two fish per fishing pass.

Guest passes will increase to \$15 for a single day pass. They will be discounted to \$10 at the annual meeting. Four guest passes are included in the annual packet.

The guest vehicle hangtag can be purchased for \$5.

TFC PARKING | ACCESS | STOCKING NOTES

- TFC has designated access to the river. Use only clearly posted access areas. Also, remain within twenty feet of the water or you could be subject to trespass charges.
- Be courteous and considerate of riverside owners.
- If you open a gate, close it. Do not fish from structures or bridges (even within access).
- Visit your HOA website for a map on parking and access points.
- Use your hangtag when parking along CR 77, around Stagestop Firehouse or at the ponds.
- Refrain from fishing on stocking days to give the fish a chance to recover from transport. Fish stocking is typically on a weekday near the middle of the week. As soon as a stocking date is confirmed, it will be listed on the HOA website(s).



Guest Passes | Discounted Passes | Membership Cards

Guest Passes: It was voted and approved to increase the guest pass price due to higher fish cost prices during the past year. The TFC was losing money for the guest pass compared to the fish cost. As a result, a one-day pass is \$15 in addition the daily fish taken by guests has been reduced from 4 fish to 2 fish, and the vehicle hangtag remain at \$5. TFC Members may purchase additional guest passes or hangtags by contacting a board member or email the TFC.

Discounted Passes: After passing by vote during the 2018 Annual Membership Meeting, there will be a discount sale of guest passes at the Annual TFC Meeting where the cost will be \$10 each.

Membership Cards: Each owner receives two membership cards to be used by the one or two owner(s) listed on the deed. In the case there are more than two owners listed on the deed, additional owners must use guest passes. As soon as you receive your membership card, print your name on it in ink and be prepared to show it to other members who are fishing or to TFC patrol.

Fishing Licenses: Anyone over age 16 who fishes in the TFC ponds or stream must obtain a CO fishing license and TFC membership card or guest pass. Annual fishing licenses are on sale March 1 and valid March 1-March 31 of the following year.

Violation Reminder | Patrolling

TFC Rules include a "Warning" section which reads: Warning - Violations of rules may be grounds for suspension. Failure of members or their guests to follow TFC Rules and Policies will result in the issuance of a "TFC Rules and Policies Violation Letter" to the sponsoring member(s). In any consecutive 2-year period, the penal-ties for violations are as follows:

- 1st Violation: Warning Letter
- 2nd Violation: \$50.00 Fine
- 3rd Violation & Subsequent: \$100.00 Fine (each occurrence)

Failure to pay a fine as outlined in the issued "TFC Rules and Policies Violation Letter" may result in temporary suspension of the member's fishing rights. During temporary suspension, a member or his/her guests continuing to fish the TFC Leased Waters as well as the LPR pond or the SS ponds will be considered "Trespassing" and subject to civil trespassing charges.

Owners are responsible for guests. When you provide a pass to someone, be sure they complete the pass in ink and know the fishing rules. If your guest is in violation of the rule(s), you will be held responsible.

Patrolling: Although TFC Board members and volunteers patrol periodically, members are encouraged to self-patrol while out fishing. Introduce yourself to others, show your membership card and ask to see their membership card or guest pass. If you encounter someone fishing without a pass completed in ink, leave and get a license plate number if possible. Then, report the incident to a TFC board member.

Renters are excluded from guest pass usage. The TFC rules were changed in 2020 to not allow owners to use guest passes as an enticement to rent their property on the short-term rental market. This is a type of remuneration since guest passes are not to be resold. It also creates a "club within a club" which is not allowed in the TFC.
